VISION IN ACTION

As COVID hopefully and finally fades in the rear-view mirror, the Pennsylvania Clinical Network closes 2022 and looks towards the new "steady state" of healthcare. The Network again rose to expected and unexpected challenges, and those experiences have better positioned our practices for success in 2023 and beyond.

The PACN expanded and launched an Accountable Care Organization (ACO) in 2022, providing essential lessons in population health management in the upside-only Medicare Shared Savings Program (MSSP). The network surpassed CMS quality benchmarks and continued our overall quality improvement trends with our other seven value-based commercial payer arrangements. This brought additional recognition back to the PACN practices for the excellent care that they are already providing their patients. Since inception, quality-based payments to practices now exceed \$2.5M. This is in addition to the \$4M to PAMED member independent practices through the Highmark Community Cares Grant in 2021.

PACN member practices continue to experience high satisfaction with the Network's responsiveness and customized support led by our expert team of Bruce Roscher, Wendy York, and Keith Taylor, along with staff who are equally dedicated to the mission to be the most trusted and successful clinical network. However, the greatest testament of PACN value comes from the words of PACN members themselves. The below comment came from one of our Family Physicians who recently transitioned back to private practice after employment:

"Corporate medicine has made it very clear that they place profits first and do not value the individual physician. In my experience as an employed physician, it was very apparent that all physicians are viewed as interchange-

able parts. I wholeheartedly believe that patients choose practices due to the individual provider and not due to the logo on the front of the building. Independence allows us to focus on the physician-patient relationship. Since converting to an independent practice, I feel my connection with patients has grown and my job satisfaction has grown. Additionally, I have found that my overall financial compensation is not much different, despite working less hours and seeing less patients.

I believe that the PACN is singularly focused on making sure I am successful."

In the PACN quest to provide our physicians with tools for success, Curi was added as a partner for medical liability insurance in addition to ProAssurance (NorCal) providing PACN member-only premium discounts. PACN care support and mental health arrangements were also added to help our physicians deliver increasingly complex care for their individual and collective patients without concurrently increasing burdens on limited practice staff and time.

Each year builds on the strength and success of the prior, and resources are reinvested back into the network to drive further quality transformation. The bold vision of the Pennsylvania Medical Society and their House of Delegates has now been realized:

"The Pennsylvania Medical Society (PAMED) must position physicians to lead and shape health care delivery to assure that the evolving system provides quality and value to patients and the community. . .[and] explore collaboration among physician-led networks and enable engagement by physicians of all practice types."

Most importantly, the participation of practices across Pennsylvania in our PACN informs all physicians, employed or independent, that there can still be a choice in their practice setting when physicians lead. The PACN remains committed to improving outcomes and will use data and analytics combined with the above puzzle pieces in 2023 to further promote preventive care and early intervention. These efforts are designed to address the root causes of health problems before they become more serious, ultimately improving short- and long-term health and reducing the overall cost of care.

Our PACN team and Network are honored to lead Pennsylvania and the nation as the only Medical Society sponsored statewide clinically integrated network. Each year, the prescient vision of PAMED becomes clearer and we are excited to demonstrate what our physician-led network will achieve in 2023 and beyond.







DR. JULIO RAMOS

When did you become the 12th District PAMED Trustee, and what drew you to seek this position? .

I became a trustee one and a half years ago, when the district 12 trustee was moving out of the area. I felt there was a good opportunity for me to give back to an institution that advocates for physicians in our area - particularly to those members that are still in independent practice. I am still learning my role as a trustee. My understanding is that the role is quite vast, but I am committed to know and understand the organization, while informing constituents (i.e., districts, special sections, or specialties) about the Society's policies during our local society board meetings and programs. I understand the needs of our community, and also report to the Board and the House of Delegates issues and concerns of the people we serve.

What made you choose to become a physician, and why rheumatology?

I was often told by my parents that I wanted to become a physician. While in college, I felt the need to understand how medicine worked, as I was one of those uninsured patients with a medical illness. I was born with a bicuspid aortic valve that ultimately would need valve replacement. When I applied to medical school, I was examined by a resident who told me I should never become a doctor, as I would need to have surgery, eventually. At that time, I didn't even have money to see a cardiologist. An independent cardiologist let me see him and did an echocardiogram - which I paid for monthly; whenever I could - while going to medical school. I was the first person in my family to have graduated with a four-year degree in college, and the only person in my family to become a doctor. I came to Scranton. My girlfriend wanted to come home, as she wanted to be near her dad, who was deaf. I was accepted to the Scranton-Temple Residency Program (STRP). During my second year, I married the love of my life Kathy, and 5 months later found out my heart was starting to fail and I needed a valve replacement. I had the replacement and went back to work, becoming a third-year Chief Resident. Just before graduating we had our first child, Gabriel, and I was offered a position as the Ambulatory Care Director for the STRP.

I came to the profession of rheumatology by chance. I was an attending physician and teacher for a residency program and Ambulatory care Director for outpatient care for two years after graduation from Internal Medicine. My friend, who was also my patient, was a rheumatologist and really needed a partner. My boss, Dr. Wright, advised me that I should take the opportunity and further my education, and if I did not like rheumatology, I would always have a position as a teacher. When I came back into town, my friend, who was to be my partner was no longer practicing. I took over his practice in Scranton, Pennsylvania. Rheumatology is a profession where we can make an impact in patients who are often very sick and often go undiagnosed for years. It allows me the opportunity to be a detective but also many times improve patient's lives, while also satisfying my pursuit for scientific discovery.

You are a PAMED Trustee and have been a PA Clinical Network member since July 2019. Why is it important for the PACN to have the support of the PA Medical Society? How does this relationship offer unique advantages to PA Clinical Network members?

Being a member of the PA Medical Society, as well as the PA Clinical Network, allows me to give a voice to independent providers in the practice of medicine.

My role as a board member for the oversight committee is basically to give support and advocate for those members who do not have a "system" behind them.

Why is it important to have independent physicians thriving in the Pennsylvania?

It is my opinion that independent physicians remain the backbone of the Medical Society, and medicine in general. Independent physicians take on the tireless job of 24/7 care while still having autonomy over their careers. Independent medical providers rarely "punch out". Patients are likely to pay more for routine health care if their doctor is employed by a hospital. Hospitals increasingly redirect services away from a physician's office toward higher cost facilities, such as Regional Medical Centers. Independent doctors don't have daily patient quotas to meet. In turn, they often spend more time with each patient and understanding their needs. This enhances the quality of care which could decrease misdiagnoses, and potentially, cost as well. When physicians spend more time with patients, they understand their needs better. This provides personalized care based on need rather than using an "if this, then that" healthcare IT formula to diagnoses or treat patients.

Unfortunately, the independent providers often get overlooked by the insurance companies, as we don't have systems or numbers behind us to negotiate reimbursement. With physicians who are employed, the cost of care for the patient is often three or four times more for the same services. These costs are passed on to insurance companies that then pass them onto the consumer, often resulting in higher insurance premiums. Independent doctors are members of the community and have a vested interest in their community's success, often volunteering and actually caring for their neighbors.



Can you speak to your role as a PACN Oversight Committee member? What successes have you witnessed as a part of this committee?

The oversight committee monitors the new and old business of the PACN, while ensuring efficiency, effectiveness, and accountability for the proposed and active processes undertaken by the PACN.

Any additional thoughts or comments to share?


I feel it is a privilege to have benefited from all the independent providers that volunteered to teach me to be a physician and my obligation to advocate and give back to a community that has given me so much.
